GENERAL RENTAL CONDITIONS

● BOOKING OF A PITCH OR RENTAL:

The campsite accepts bookings for its pitches and rentals in order to guarantee its customers a place on the day of their arrivals. These bookings are submitted to some conditions: any booking form shall be accompanied with a deposit. Each booking is only effective and definitive after reception of the booking form properly completed, dated and signed, as well as the deposit, and after the campsite sends back a booking voucher for confirmation.

NB: The booking is personal: it is forbidden to sublet or give it to a third party. Any change of the number of participants must be signaled to the reception prior to the arrival. The number of people indicated for each rental is a maximum per accommodation (children and babies included). Any change of the reservation shall be reported prior to your arrival and will only be possible after acceptance from the campsite. In case of misstatement, the present form will be terminated and the payments previously made will remain to the campsite.

Any camper/tenant must upon arrival, check in at the reception to settle the arrival formalities. The keys of the accommodations will then be given. To access the campsite, the bracelet is compulsory in July and August.

● **BOOKING FEES AND DEPOSIT:** The deposit is 30% of the total amount (booking fees included - 26€ in high season, July and August; 13€ in low season). It is nonrefundable for the rental of a mobile-home, lodge, cottage or pitch with private sanitary.

● BALANCE OF THE STAY:

The balance must be paid 30 days before the arrival date. If we have not received the payment, we will consider your booking cancelled and any prior payments shall remain to the campsite. For any bookings made less than 30 days before the arrival date, you will be asked to pay the total amount, at the time of the reservation.

- **For a pitch**, the balance and the city tax shall be paid 30 days prior to the arrival. The pitch will be available on the arrival date from 3pm, until the departure date specified on the booking form, before 12pm (an appointment as to be taken at the reception desk).

- **For an accommodation**, the balance and the city tax shall be paid 30 days prior to the arrival. The accommodation will be available on the arrival date from 4pm, until the departure date specified on the booking form, before 12pm (an appointment as to be taken at the reception desk).

● **FORM OF PAYMENT ACCEPTED:** Credit card and bank transfer.

● DELAYED ARRIVAL OR ANTICIPATED DEPARTURE:

You must advise the campsite of any delay in your arrival, in order to keep your rental. The director keeps the right to use the rental if left without news, 24 hours after the planned arrival date. No refund or discount will be possible, in case of a delayed arrival or anticipated departure.

● SECURITY DEPOSIT:

For each accommodation, or pitch with private sanitary, a security deposit of 300 Euros will be asked upon the arrival to cover any potential damage; it includes an 80 Euros cleaning deposit, which covers potential cleaning fees at the end of the rental. It will be restituted on the day of departure (after checking by the campsite staff) excluding potential damages observed during the checking. The cleaning is to be done by the camper/tenant, who must give the accommodation back as clean as he found it on the day of arrival. At the end of the stay, the rental and its surroundings must be clean; otherwise the 80 Euros deposit would be kept.

The equipment of each rental is part of a priced inventory. The tenant is asked to check it upon his arrival and report any anomaly to the reception desk. Each rental has all the equipment for cooking, bed protections, pillows and covers. The bedsheets and pillow cases are not included (it is possible to rent them).

● **CANCELLATION:** Any cancellation of the stay will not lead to a refund. For any stay cancelled before its arrival date, all the payments already made will remain to the campsite (the deposit, the booking fees). Once the stay has started the total of the payments made will remain to the campsite. There will be no refund possible, no matter the cause.

● CANCELLATION INSURANCE AND INTERRUPTION OF THE STAY (Recommended):

4.5% of the cost of the stay, with a minimum fee of 20€. Refund of the penalties in case of cancellation or change of the stay for a guaranteed cause. Refund of the costs already paid and unused in case of anticipated departure. The cancellation insurance shall be paid entirely at the time of the booking. It adds to the deposit and regards the participants of the stay. No refund will be done without subscription to this insurance (see the general conditions on our website www.camping-levasion.fr). THE CAMPER/TENNANT MUST HAVE A LIABILITY INSURANCE.

● **PREFERENCE:** The campsite cannot guarantee the special requests made upon a reservation (pitch number or else...). Your pitch number is not contractual and will not be given to you before your arrival.

● **RIGHT OF PUBLICITY:** By accepting the general conditions, you authorize the campsite to use any video/photography of you and any participant to this stay, which might be taken during your holidays, for the publicity of the campsite (brochure, website, inset...) and this, without limitation of time.

● **NOISE AND DISTURBANCES:** The offenders will be expelled with no refund.

● ACCESS TO THE AQUATIC PARK:

To access the campsite, it is compulsory to wear the bracelet in July and August. Any person not mentioned on the form will be denied the access to the pools. Children must be accompanied by an adult (see regulations of the aquatic park). Due to the high hygiene regulations from the ARS, swimming shorts and underwear are forbidden in our pools.

Attributive clause of jurisdiction: the legal disputes will be treated exclusively by the Court of Les Sables d'Olonne.

Each camper, tenant or visitor must respect the INTERNAL REGULATIONS of Campsite l'Evasion displayed at the reception.
